# Young Children and Technology

Science confirms what early care and education professionals have known for years, that infant, toddlers and preschool children learn best through exploring the environment with their whole bodies and need a great deal of one-on-one interactions, yet young children are spending more and more time engaged with screen technologies. While technology can be a tool to support early learning, technology cannot take the place of creative play and powerful interactions with caring adults. Effective uses of technology are handson, engaging and used as a support for children's learning.

The National Association for the Education of Young Children and the Fred Rogers Center have published the following recommendations to guide early care and education professionals in the use of technology with young children:

1. Select, use, integrate, and evaluate technology and interactive media tools in intentional and developmentally appropriate ways, giving careful attention



to the appropriateness and the quality of the content, the child's experience, and the opportunities for co-engagement.

- 2. Provide a balance of activities in programs for young children, recognizing that technology and interactive media can be valuable tools when used intentionally with children to extend and support active, handson, creative, and authentic engagement with those around them and with their world.
- 3. Prohibit the passive use of television, videos, DVDs, and other non-interactive technologies and media in early childhood programs for children younger than 2, and discourage passive and non-interactive uses with children ages 2 through 5.
- 4. Limit any use of technology and interactive media in programs for children younger than 2 to those that appropriately support responsive interactions between caregivers and children and that strengthen adult-child relationships.
- 5. Carefully consider the screen time recommendations from public health organizations for children from birth through age 5 when determining appropriate limits on technology and media use in early childhood settings.

6. Provide leadership in ensuring equitable access to technology and interactive media experiences for the children in their care and for parents and families

# First Year Family Child Care Provider? If so, check this out!

### **Training Track and Mentoring for First Year Family Child Care Providers**

First year registered family child care providers must take 18 hours of continued training during the first year of operation. In order to assist in meeting this requirement, and to offer you the opportunity to become part of a peer support group, BCCCRC offers a training and mentoring tract just for first year providers. For a fee of \$120 you can take eighteen- hours of training and participate in a mentoring group which will meet three times. # Summer Safety Tips from the Center for Disease Control and Prevention



Summer is a great time for kids to enjoy different indoor and outdoor activities. Whether they are young children or teens, learn ways to keep your kids safe and healthy while they enjoy the summer fun.

#### Master water safety

Water-related activities are popular for getting physical activity and have many health benefits. Here are some tips to stay safe while having fun.

Drownings are the leading cause of injury death for young children ages 1 to 4, and three children die every day as a result of drowning.

- Always supervise children when in or around water. A responsible adult should constantly watch young children.
- Teach kids to swim. Formal swimming lessons can protect young children from drowning.
- Learn cardiopulmonary resuscitation (CPR). Your CPR skills could save someone's life.
- Install a four-sided fence around home pools.

#### Beat the heat and sun

Heat-related illness happens when the body's temperature control system is overloaded. Infants and children up to 4 years of age are at greatest risk. Even young and healthy people can get sick from the heat if they participate in strenuous physical activities during hot weather. For heat-related illness, the best defense is prevention.

• Never leave infants, children, or pets in a parked car, even if the windows are cracked open.

- Dress infants and children in loose, lightweight, light-colored clothing.
- Schedule outdoor activities carefully, for morning and evening hours.
- Stay cool with cool showers or baths.
- Seek medical care immediate if your child has symptoms of heatrelated illness.

Just a few serious sunburns can increase you and your child's risk of skin cancer later in life. Their skin needs protection from the sun's harmful ultraviolet (UV) rays whenever they're outdoors.

- Cover up. Clothing that covers your and your child's skin helps protect against UV rays.
- Use sunscreen with at least SPF (sun protection factor) 15 and UVA (ultraviolet A) and UVB (ultraviolet B) protection every time you and your child go outside.

#### Keep mosquitos and ticks from bugging you this summer

Protect yourself and your family by preventing bites and diseases, like Zika, West Nile virus and Lyme disease, which can be transmitted by insects.

- Use an effective insect repellent while playing outdoors.
- Make your backyard a tick-safe zone.
- Check yourself and your children for ticks. Ticks are easy to remove.
