#### Child Care in the Digital Age!

ver the past few years there has been a large push as the state of Maryland transitions to a more digital friendly place. During the start of COVID-19 our children learned how to participate in their daily school activities from the comfort of their homes and in child care programs with the support of their teachers and families. During 2023 MSDE's Office of Child Care has started transitioning to a more digital friendly, paperless platform with the introduction of MSDE's Child Care Provider Portal. It is extremely important that all Family Child Care Professionals and Child Care Center Owners/Directors have reliable access to a computer for your child care business.

#### **MSDE's Child Care Provider Portal**

The Child Care Provider Portal allows providers to renew child care licensure, view invoices and payment history, manage attendance, view scholarship requests, and more. Effective November 20th all child care providers with families enrolled in the Child Care Scholarship Program are required to have an account in the Child





Care Provider Portal. The Portal supports the provider by improving communication and customer service with automatic notifications of next steps. You will also be able to do the following:

- Manage Your Child Care License
- Invoice & Payment History
- Manage and Track Attendance
- Upload Documents
- View Scholarship Requests

### Did you know?

In partnership with Baltimore City Information & Technology and the Maryland Office of Statewide Broadband Pratt Library will be distributing 30,000 HP Chromebooks to eligible Baltimore City households. Distribution events will be held at various Pratt locations and local community sites. Through the Maryland Connected Devices Program (MD-CDP), efforts will continue to decrease the digital divide and increase digital literacy in the Baltimore City community.

- Mobile Hotspots Customers aged 13 and older can borrow a mobile hotspot and connect up to 15 devices to free Wi-Fi.
- Borrow a Chromebook Customers aged 13 and older can borrow a Chromebook, complete with power adapter/cord and carrying case, from the Pratt Library.
- Chromebook Distribution The Pratt Library is distributing 30,000 HP Chromebooks to eligible Baltimore City households.
- Long-Term Device Lending for Partners: Local organizations can borrow Chromebooks from the Pratt for long-term lending.

# Required Basic Health and Safety Training

The Basic Health and Safety Training update for calendar year 2023 is now available. The training is free and only available online. The training must be completed by March 31, 2024. All family child care providers and child care center staff are required to complete this annual update. Upon completion of the course, individuals will be awarded 1.5 hours of continued training. Please note, this training update is in addition to the 3-hour COMAR training. Staff hired during December 2023 must complete the 3-hour Basic Health and Safety training by March 31, 2024.

# **Money Matters**

#### **Good News at Tax Time**

Hefty Credits Help Working Families put extra cash in their pockets at tax time by claiming the Earned Income Credit (EIC). The EIC is a tax provision that allows eligible taxpayers to reduce their tax burden.

Families may qualify for the federal and state EIC, if, in 2023, they:

- were raising one child and earned less than \$46,560; or less than \$53,210 if married.
- were raising two children and earned less than \$52,918; or \$59,478, if married.
- were raising three or more children and earned less than \$56,838; or \$63,398 if married.
- had no children, earned less than \$17,640; or \$24,210 if married.

The EIC is the biggest tax benefit for working families, but there are other important tax credits. You could be Eligible for a Bonus under the new Bonus Structure! The Maryland State Department of Education will be distributing \$5 million in bonuses to child care programs participating in Maryland EXCELS as part of the transformative Blueprint for Maryland's Future landmark legislation. Eligible programs will receive bonuses ranging from \$1,000 to \$13,500 based on the type of program, quality rating, and capacity.

# MARYLAND CHILD CARE RESOURCE NETWORK COMPLAINT POLICY

Every member agency of the Maryland Child Care Resource Network strives to provide high quality service to the child care programs and families in their jurisdiction and throughout Maryland. It is our mission to ensure that every interaction with staff at the Child Care Resource Centers is positive and professional.

If you have concerns about an incident or some aspect of service at a Child Care Resource Center, please contact the director/manager directly. If you are not satisfied with the way your concern is handled by the director/manager at the Child Care Resource Center, please contact Maryland Family Network at 410-659-7701 or at MCCRNinfo@marylandfamilynetwork.org. As the Statewide Coordinating Entity of the Maryland Child Care Resource Network, MFN will investigate the complaint or concern regarding services and take appropriate action.



#### **LOCATE COMPLAINT POLICY**

Through the LOCATE service, parents share feedback with the LOCATE staff on the programs in the files: licensed child care centers, registered family child care providers and accredited preschools and camps. While this feedback is at times positive, it sometimes concerns complaints parents have about child caregivers. Of course, LOCATE and the Maryland Child Care Resource Network want to use this information in a way that is fair to providers and parents, while protecting children, as well. Therefore, the LOCATE Complaint Policy was developed and has been in effect since its approval by the Maryland Committee for Children Board in November, 1983. According to this policy, all complaints made to LOCATE about child care providers/facilities are recorded. The type of complaint is then determined: Less Serious Complaint - No Violation: complaints which do not involve violations of child care regulations; complaints about situations which do not pose a threat to the safety, health or welfare of a child. Less Serious Complaint Involving Violation: complaints of any violation of Office of Child Care (OCC), Maryland State Department of Education (MSDE) regulations, and/or the Health Department which do not pose a threat to the health, safety or welfare of a child. Serious Complaint: any threat to the immediate health, safety, or welfare of a child. When a parent calls LOCATE with a complaint, the referral specialist advises him/her to register the complaint directly with the appropriate regulatory agency and/or Protective Services. Names and telephone numbers of the person with whom the parent should speak are provided. When a Serious Complaint is received concerning one of the providers of facilities in the LOCATE system, no referrals are made by the referral specialists to that provider/facility. The LOCATE Director also communicates with the appropriate regulatory agency personnel about the complaint, and maintains the "hold" on the provider/facility until the agency's disposition of the complaint is known. Should the investigation result in no action, the "hold" status is removed from that provider's/ facility's records. Should the license or registration be revoked, the record is removed from the LOCATE files. Providers are advised of LOCATE's actions in writing. A provider may appeal the LOCATE Director's decision to cease referrals. Appeals are first addressed to the LOCATE Advisory Committee. Final appeals may be made to the board of the Maryland Family Network. It is the position of LOCATE and MFN that the Complaint Policy is both fair and workable. Safeguards and due process are afforded to the care givers in the files, and parents' and children's rights to safety are addressed, as well.
